Issue:

- The function `excludeMultipleAccountsFromFees()` uses the loop to exclude addresses from the list. Function will be aborted with `OUT_OF_GAS` exception if there will be a long addresses list.

Recommendation:




Check that the array length is not too big.

Owner privileges (In the period when the owner is not renounced)



- Owner can change router and pair address.
- Owner can add market maker pairs addresses.
- Owner can exclude from the fees.
- Owner can enable trading.
- Owner can change sell/buy taxes.
- Owner can change marketingTaxThreshold.
- Owner can change marketing address.
